

Article-1
OBJECTIVE OF COLLABORATION

Article-2
SCOPE OF COLLABORATION

The Parties agree to implement collaborative programmes including but not limited to:

1. Joint teaching-learning and internship
2. Collaboration in the area of research, publications, project work, etc.
3. Joint field trip, excursion, and education tour,
4. Joint training, add-on, certificate and vocational courses.
5. Joint extension activities, consultancy.
6. Joint faculty and staff development programmes.
7. Co-hosting and participation in conferences, seminars, symposiums, and workshops, book fairs etc.
8. Collaborative programmes in Capacity building and skills enhancement initiatives like Soft skills, Language and communication skills,
9. Collaborative programmes in Life skills (Yoga, physical fitness, health and hygiene),
10. Collaborative programmes in ICT/computing skills,
11. Collaborative programmes in competitive examinations, career counselling, sports and cultural events,
12. Any other activity that is mutually agreed upon and is beneficial to both.

Article-3

FINANCIALARRANGEMENT

Any collaboration under this MOU is subject to the availability of approval of the relevant authorities.

Article-4
LOCATION OF ACTIVITIES

1. The Parties agree to implement the programmes stated in Article2 at SANTALBIDROHASARDHA SATABARSHIKI MAHAVIDYALAYA and VIDYASAGAR METROPOLITAN COLLEGE.
2. Any changes of the location of the programmes shall be mutually agreed upon by the Parties.

Article-5

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted in blended mode (offline and online).

Article-6

CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both the institutions shall respect and retain confidentially in each/ any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other /commercial interest. This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Article-7


DURATION AND TERMINATION

- 1) This MOU shall enter in to force on the date of signing.
- 2) The MOU shall remain in force for a period of five (5) years and maybe extended for another period of three (3) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at anytime by giving written notice to the other Party on its intention to terminate this MOU, at least six (6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article-8

AMENDMENT

- 1) This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.
- 2) Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.
